# "Enterprises, Insularity and Competitiveness"

Program

The 2002 Insuleur Forum in Sardinia gave us a chance to focus on to the structural handicaps which island SMEs are forced to live with, and we offered some possible solutions and remedies. One year later, the context has changed. The European Union is at a crossroad, ready to take up two great challenges - the Enlargement and the implementation of the Lisbon strategy for economic, social and environmental renewal.

The current cohesion policies will definitely change. And while the European Commission works on this far reaching reform, it becomes more and more evident that *competitiveness* and *convergence* will be two important keywords.

We need to get ready for the new, larger Europe. This is the reason why the theme for the 4th Insuleur Forum "Corse 2003" will be "Businesses, Insularity and Competitiveness". Anticipating the restructuring of the EU cohesion policies means finding resources and building new strategies that will allow the island SMEs to be competitive and, therefore, assure their survival.

Out of all the European island regions, 34 Chambers of commerce will be in Ajaccio for the 4th Insuleur Forum. Together we will try to understand up to what point and how the handicap of insularity can be overcome. We need to encourage entrepreneurship on our islands and guarantee all our SMEs the means to grow and become more and more competitive on the global market. Only the creation of new business opportunities and healthy enterprises can make our island regions more dynamic and vital.

We are deeply convinced that no *magic formula* will let island SMEs compete on a fair and level playing field with their continental counterparts. We will need a strong resolve on our part. In the meantime, we will keep asking Europe to accept the fact that island regions are not like other regions.
